Top 3 overall must attend. All others CAN be mailed.</p>	<p style="text-align: center;">Boundaries</p> <p>Fishing will be restricted to within 5 miles of the Door County shoreline with the southern boundary being a line running from Brown County line (N44*40'39.6510", W-87*59'5004") to the Kewaunee County line (N44*40'36.8898", W- 87*44'8026") and the boundary being Gills Rock (N45*17'38.9724", W-87*1'23.0376") again, maintaining the 5-mile limit. Waters within 1.5 miles of Chambers Island may be fished. No fishing permitted east of buoys #5 & #6 at the US Coast Guard Station located toward Lake Michigan from Sturgeon Bay. There will be no fishing allowed in Lake Michigan. Any waters within these boundaries posted "off limits" or "no fishing" by state or federal agencies will be off limit. Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to public will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
<p style="text-align: center;">Fish Limits</p> <p>Fish size: Large and smallmouth 15 inches and over. Only ONE fish can be weighed per person per session. Only 2 fish in the live well per person at any time. Culling is allowed, culling a DEAD bass is prohibited.</p> <p>NO LIVE BAIT IS ALLOWED, NO trolling is allowed. 1 rod per person in use.</p> <p>Follow Wisconsin Regulations.</p>	<p style="text-align: center;">Required Safety Equipment</p> <p>It is the responsibility of all anglers to have and to daily CHECK all required state and federal safety equipment on board.</p> <p>Any of the following can be checked, at any weigh in be prepared: Fishing License, # fish per angler, life jackets; 1 throwable PFD; NO alcohol in the boat, and functioning kill switch.</p>	<p>Stay up-to-date sign up for the FREE e-newsletter at: northamericanbasschallenge.com</p> <p style="text-align: center;">Please READ the Official Big Fish Event Rules</p> <p>Host Hotel – Beach Harbor Resort, 3662 N.
